I further acknowledge that the *Tour of the Peanut Country* will be conducted over public roads and facilities open to the public during the event and upon which the hazards of traveling are to be expected. I understand that a bicycle is legal vehicle in the State of Texas and that I must ride in a legal and safe manner.
